

APPROPRIATION RESOLUTION #1, 2016-2017

WHEREAS, on the **14th day of July, 2016**, Lori Smallwood, Big Horn County Clerk, the budget making authority, prepared and submitted to the Board a county budget for the **2016-2017** fiscal year ending **June 30, 2017**.

WHEREAS, such a budget was duly entered at large upon the records of this Board on the 17th day of May, 2016, and a copy thereof was made available for public inspection at the office of the County Clerk; and

WHEREAS, notice of a public hearing on such budget, together with the summary of said budget, was published in the Basin Republican Rustler, Greybull Standard, and the Lovell Chronicle, legal newspapers published and of general circulation in the county on the 7th day of July, 2016; and

WHEREAS, following such public hearing certain alterations and revisions made in such proposed budget, all of which more fully appear in the minutes of this Board.

NOW, THEREFORE, BE IT RESOLVED, by the Board of County Commissioners that the county budget, as so revised and altered, be adopted as the official county budget of the fiscal year ending June 30, 2017.

BE IT FURTHER RESOLVED, that the following appropriations be made for the **2016-2017** fiscal year ending **June 30, 2017**, and that the expenditures of each office, department or spending agency be limited to the amount herein appropriated.
