**2016 FISCAL YEAR BUDGET AND ASSESSMENT ORDER**

THIS MATTER coming on for hearing on June 25, 2015, upon the 2016 Fiscal Year Budget Report of Commissioners of the Sidon Irrigation District filed herein, as required by W. S. §41-7-402;

The Court having made on May 28, 2015, an Order Fixing Time and Place of Hearing and setting for June 25, 2015, at the hour of 11:00 a.m. in the courtroom of the Courthouse in Basin, Big Horn County, Wyoming, as the time for hearing and it further appearing that notice of time and place of said hearing has been given as provided therein by posting a copy of the Court's order dated May 28, 2015, on the Courthouse bulletin board in the Courthouse in Basin, Big Horn County, Wyoming, on May 29, 2015, and on the bulletin board at the office of Sidon Irrigation, Cowley, Wyoming, on June 9, 2015, and continuously thereafter;


No objections having been filed and no persons being present to protest in person and the Court being fully advised in the premises;

The Court finds that said report contains a proper estimate of the expenses of the irrigation district during the fiscal year 2016, and that said report should be and the same is hereby confirmed and approved as the basis for the budget of said irrigation district for the fiscal year 2016.

IT IS THEREFORE HEREBY ORDERED, ADJUDGED AND DECREED that the report of the Commissioners of the Sidon Irrigation District filed herein in the amount of \$491,300.00 be and the same is hereby confirmed, approved and adopted as the budget for the fiscal year 2016, for the operation and maintenance of the irrigation system, and to replenish the Reserve/Emergency Fund with an annual assessment of \$29.00 per acre, or \$22.00 minimum assessment for those properties of less than one acre, against the property entitled to receive water from the Sidon Irrigation District.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the oil royalty budget shall be \$336,286.00 and the same is hereby confirmed, approved and adopted as the oil royalty budget for fiscal year 2016.
