ORDER

THIS MATTER, came to be heard by the Court on this 7 day of April, 2015 upon the report of the Hunt Canal Irrigation District for the budget of 2015 and pursuant to an Order heretofore entered fixing the time and place for hearing on said report: and the Court having examined said report does hereby fix and determine the amount to be raised by the assessments in said district at \$36,470.25 for expenses and repayment of the principal interest to WCDA, in the year, 2016.

IT IS THEREFORE ORDERED, THAT THE Commissioners of Hunt Canal Irrigation District levy the sum of \$21,574.19 for expenses for the year, 2015, and they shall add to a certified copy of this order, the amount of (\$14,896.06) necessary to be levied for said year to meet the principal and interest of lawful indebtedness of the District maturing during the current year, and when so completed, it shall be know as the budget for the Hunt Canal Irrigation District and so certified to the Board of County Commissioners of Big Horn County, Wyoming for assessment as provided by law.

That during the ensuing year the commissioners will require the following sums of money, which must be raised by assessments against the lands in said district, to wit;

OPERATING EXPENSES \$21,574.19
REPAYMENT OF WCDA LOAN \$14,896.06
\$36,470.25

WHEREFORE, your commissioners pray that the court fix a time and place for the hearing on this report, and that on said hearing the court approve an assessment amount of \$9.00 per acre which is sufficient to cover our operating expenses INCLUDING the repayment of the WCDA Loan to the State of Wyoming. We do have a CD, which will cover the WCDA Loan payment in case of a shortfall of collections.
